Whereas undersigned has been appointed as Returning Officer by the Registrar co-operative societies vide order No. F.47/954/GH/Coop/Sec-III/RCS/2018/5682 dated 31.10.2018 to hold the Election of the Managing Committee of the Janaki co-operative Group Housing Society Ltd. Plot no. 7, Sector-22, Dwarka, New Delhi-110077.

Now, therefore, I, Manoj Kaushik, Returning Officer of the Janaki co-operative Group Housing Society Ltd., hereby call a Special General Body Meeting of the aforesaid society on 27.01.2019 (Sunday) at 09:15 AM in the society premises of Janaki co-operative Group Housing Society Ltd. Plot no. 7, Sector-22, Dwarka, New Delhi-110077 for conducting the election for One(1) post of President, One(1) post of Vice President and Nine (9) posts of Managing committee members, (out of which Two posts are reserved for Women Members as per DCS Rules 2007). The election of the managing committee are being held under the provisions of DCS Act 2003 and the term of Managing Committee shall be for 3 (three) years.

The nomination forms can be obtained free of cost from the office of society on 11.01.2019 from 11:00AM to 4:00PM. The nomination forms duly filled alongwith security deposit of Rs. 1000/- (One Thousand Rupees only) in cash should be handed over to the undersigned by the candidate or proposer or seconder on the date and time mentioned above. **Candidates, their proposer and seconder must not be a defaulter member.** A person shall not be eligible to contest election for two posts simultaneously. In case a candidate submit his/her nomination for more than one post the member shall intimate his/her final choice at the time of withdrawal. A member shall not be eligible to contest for the election, if he/she has not completed minimum period of one year from date of acquiring membership in the Society. In case, the candidate gets less than 1/6 of the total votes polled, the security deposit shall be forfeited.

The list of members and defaulters of the aforesaid Society is displayed at the office of undersigned at the office of Janaki CGHS Ltd. Members can obtain a copy of the list of members from the Office of the Society on payment of prescribed fee as per Rules.

**SPECIAL NOTE**


1. The Election / meeting shall start on 27.01.2019 (Sunday) at 09:15 AM in the Premises of the Janaki co-operative Group Housing Society Ltd., Plot no. 7, Sector-22, Dwarka, New Delhi-110077. The quorum of the meeting will be observed for HALF AN HOUR i.e. from 09:15A.M. TO 09:45A.M. and in case, the quorum is not completed upto 09:45AM, the meeting shall be adjourned for 15(Fifteen) minutes i.e. from 09:45 AM to 10:00 AM. The adjourned meeting for the election shall take place from 10:00 AM to 02:00 PM on the same day at same place for which no quorum shall be necessary in terms of the Rules 48 (3) of the DCS Rules, 2007.

2. The election shall be conducted as per provisions of Delhi Cooperative Societies Act 2003 and Delhi Cooperative Societies Rules 2007. It is not possible to explain all the provisions, all the concerned members are requested to please read and understand all provisions of DCS Act 2003 and DCS Rules 2007.

**COUNTING OF VOTES**


The counting of votes will start immediately after the polling is over and result will be declared immediately after completion of the counting.

Note:- All the members are requested to bring their identification by way of society I.D. card/License/Voter ID card/ Aadhar card/ Photo ID card issued by the Govt. for their identification to avoid any inconvenience for casting their vote.

As per provision of DCS Act 2003 & DCS Rules 2007, the defaulter members are neither eligible to contest the election nor entitled to cast their votes. However, in case they make payment to the Society of their dues before the date of filing nominations and produce the proof thereof before the undersigned, they will not be treated as defaulter and shall be allowed to contest the election or cast their votes. It is informed that lists of members / defaulters are available with the Returning Officer and also displayed on the Society Notice Board. Members are advised to check the list of defaulter / member to avoid any inconvenience at the time of filing of nominations or at the time of polling. It is further informed that no person shall be eligible to contest election if he incurs disqualification as laid down u/s 25 (d) of DCS Acts 2003 read with Rule 54 of DCS Rules 2007.
